## **Introduction**

### **Stand 113 - Pinnacle Point Beach and Golf Resort**

Specifications (suggested reading in conjunction with the plans):

This villa is 440 sqm in size.

The ground floor consists of a fully equipped kitchen and scullery with high quality appliances, a dining room, TV lounge and games room. A fireplace serves the dining and games room. The guest bathroom serves the ground floor. The entire dining and TV area opens up with its fold away stack doors onto the wooden sundeck and rim flow swimming pool. Next to the pool is an undercover patio with a built-in braai and an outside dining area.

On the first floor there are 4 fully air-conditioned bedrooms with full en-suite bathrooms. Two of the bedrooms have queen beds where the other two have 2x single beds each. Each bedroom leads onto a private balcony.

There is an automated double car and single golf cart garage with your own golf cart at your disposal.

The villa sleeps 8 People and is self catering

Check-in and Check-out

The check in time is at 2pm on your date of arrival and 10am on your date of departure.

Upon your arrival at Pinnacle Point you need to report to the Pinnacle Point Reception Office. Your ID needs to be presented to them. You need to inform Jarkie Property Management of you arrival, please supply them with full names of all guests, car registration number and rental car information prior to your arrival. Please ask them for the directions to your villa, as it can be quite tricky. The keys to the villa will be at the front door of the villa in a key safe whereby you will be provided with that pin upon you arrival. Upon departure, visitor's should return the keys to the key safe.

Home attendant's working hours is from Monday - Friday 9am to 4pm and Saturday 9am – 12:30pm.

## **Rules and Regulations**

- Smoking inside the villa and in the golf cart is not allowed.
- Speed limits within the Resort should be adhered to at all times.
- Only discreet music is allowed until 10pm. No music will be allowed thereafter. The same applies to voices. Voices travel far and it is expected to keep noise levels to a minimum.
- Home attendants may not wash personal clothes. Washing machine and tumble dryer are at your disposal.
- No pets are allowed on the Estate.
- A R350 fee applies on late check-outs.
- A fee will be charged if the keys have not been returned to the key safe upon your departure or have been lost.
- The swimming pool has a safety net. Once the safety net has been taken off the swimming pool it is the visitor's responsibility to manage the safety of children and all parties staying in the property. The owner, shareholders, managing agent, service provider, exchange and rental agent can not be held responsible for the safety of visitors. The pool net must be put back on the pool when not in use as the estate security also issues fines of R1500 for this if found off.
- Only persons with a valid drivers licence may operate the golf cart.
- A maximum of 4 people on the golf cart.
- After each and every usage of the golf cart the golf cart should be plugged into the charger. This is important for the lifespan of the golf cart batteries.
- The Estate Rules must please be read and adhered to at all times as there are major fines issued for breaking of the estate rules eg: Cutting of fynbos and littering in the estate.
- Guests are NOT allowed to destroy fynbos in any manner – eg: walking on it (an owner was issued with a R5000 fine for cutting fynbos for display in her home) We are not even allowed to cut fynbos where it is obscuring the view of the golf course.
- This is a privately owned villa and the owners requested you to thoroughly enjoy all the benefits that this villa has to offer, but also to treat the villa with the necessary respect as if it was your own.
